2. Getting to know the office/department and its divisions.
3. Meet the client, if possible, or know the requirements of the client/owner of the project.

5. Find out how to obtain a license, if possible.
6. Dealing with various architectural programs, for example AutoCAD, Revit, Lumion, 3dMax, Photoshop and others.
7. Participation in the design work of some buildings at the office.

9. A field visit to the project site.
